Documents required

- 1. A letter of application signed by the head of the organization;
- Application form, completed and signed, including supporting documentation as indicated in the form such as:
- documents specifying the nature and identity of the organization, including evidence of nonprofit status (e.g. certificate of registration or establishment, tax-exempt status);
- documents detailing the aims/objectives and main activities of the organization, including its geographical scope (e.g. statutes, by-laws);
- documents detailing the human resources, sources of funding, membership and governance of the organization (e.g. annual report, including financial report);
- information supporting claims, if any, that the organization is in formal relations with other organizations/bodies of the United Nations system;
- documents that indicate the organization's competence in matters related to the WHO FCTC (preferably with reference to specific articles of the Convention).

Documents required

- Letter of application from the head of the organization.
- Certified copies of documents detailing the mandate, scope and governing structure of the organization
- Certificate of incorporation/registration/establishment of the organization
- 4. Certificate of the non-profit and/or tax-exempt status of the organization
- A recent annual report, including a financial statement that provides information expenditure of the organization;
- List of donors and other funding sources in the last two years unless the organization is one year old. The treatment of the information is strictly confidential;
- Information on activities undertaken by the organization in the last 12 months that indicate the competence of the organization in matters relating to the UNFCCC, such as newsletters and other publications:
- Information on the affiliation of the organization with other non-governmental organizations or networks involved in climate change activities;
- 9. Completed contact details form,
- 10. In the case of research institutes, including universities, a document that proves academic independence of the organization.

NGOs with observer status to the COP will be requested to submit a report on their activities to the Secretariat every two years. Such reports shall be submitted at the latest six months before the opening of the next session of the COP. In this regard, the COP adopted a standard reporting questionnaire to be used by NGOs which will be available on web-based format in due course.
